HEALTH INITIATIVES- UWM PROMOTES ACCESS TO PRIMARY HEALTH CARE AS WELL AS DENTAL AND EYE CARE FOR PEOPLE WHO ARE UNDERINSURED OR LACK INSURANCE AT ALL. UNITED WAY PROGRAMS AND INVESTMENTS HELPED NEARLY 2500 PEOPLE ACCESS HEALTH CARE, HELPED ANOTHER 951 CHILDREN AND ADULTS OBTAIN DENTAL CARE, AND MORE THAN 1100 ADULTS GET EYE CARE.
